### 3. Eligible Candidates for Special Round of OFFLINE Counselling

The eligibility of Candidates to participate in the Special Round of OFFLINE Counselling has already been stated in

(i) University Notification No. 223/2020 and Letter no.IPU-7/Online Counselling/2020/998 dated 01.01.2021

(ii) University's Notification No.225/2020 & 226/2020, dated 04.01.2020.

**Important Note:-** Only those candidates who fulfill the eligibility as per above University notification and subsequent to the above notifications have Registered through ONLINE mode by paying participation fee of Rs.1100/- shall only be allowed to participate in Special Round of OFFLINE Counselling.

4. Merely participation by NON-ADMITTED Candidates in Special Round of OFFLINE Counselling does not guarantee an admission to the such candidate in his / her choice of College or Stream and the allotment of a seat shall be purely on the basis of merit of candidate keeping in view the CUT OFF of allotment of the respective college in the previous online counseling.

### 5. Eligibility Criteria for above mentioned programmes

The candidates are required to kindly go through the eligibility criteria laid down in the Admission Brochure for Academic Session 2020-21 available on the University Website [www.ipu.ac.in](http://www.ipu.ac.in) for a particular programme / course. Seats shall be allocated on the basis of all India basis purely on CET/National Level Test Rank /irrespective of Region and category.

### 6. Documents Required for Allotment of Seats:

- Bank Draft(s) of Rs. 50,000/- in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s). Balance fee has to be paid at their respective college.
- Filled Admission verification** form by the Candidate as per Appendix 4A in Part E of Admission Brochure 2020-21.
- Filled Preference Sheet** by the Candidate as per Appendix 7 in Part E of Admission Brochure 2020-21.
- Four passport sized photographs (same as that in admit card)
- CET/ National Level Test Registration details (Photocopy and Original)
- CET 2020 Admit Card in original and CET 2020 Result

- g) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- h) **Mark-sheets / Certificates of qualifying examination:**  
The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.
- i) **Physical Fitness Certificate:**  
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2020-21 (As per Appendix 6).
- j). **Conduct and Character Certificate** in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- k). **Undertaking from the candidate** who wishes to participate in Special Round of Counselling (format attached).

## NOTE:

- (i) The balance amount of fees i.e. 29,000/- (Twenty Nine Thousand Only) in respective University School of Studies may be submitted through Demand Draft in favour of "Registrar, Guru Gobind Singh Indraprastha University" after Reporting.
- (ii) In Affiliated Colleges/ Institutes of GGSIPU, the balance amount of fees may be submitted through both online (Net Banking/ Credit Card/ Debit Card) / offline mode (Through Draft) as per the instructions issued by the respective Affiliated College / Institute.

## 7. In Result Awaited / Compartment / Supplementary Cases:

All such candidates who have appeared in the qualifying examination (irrespective of the outcome of their final result) will have to submit the final result of qualifying degree proving his/her eligibility on or before 31<sup>st</sup> January 2021 to their concerned Dean/Principal/Director of their respective School/College/Institute where the admission has been granted provisionally.

The concerned Dean/Principal/Director will ensure that those candidates who have taken provisional admission on the basis undertaking that they will submit the result by 31<sup>st</sup> January 2021 and if fail to do so by 31<sup>st</sup> January 2021 shall not be allowed to sit in classes w.e.f. 1<sup>st</sup> February, 2021. The Dean / Principal / Director shall submit the list with the details of such candidates to the University by 31<sup>st</sup> January 2021. The Dean / Principal / Director shall be responsible to ensure mechanism to monitor the cases of such candidates admitted provisionally to ensure that the candidates are informed prior to 31<sup>st</sup> January 2021 that failure to submit the result by 31<sup>st</sup> January 2021 shall result in cancellation of their provisional admission. The Dean / Principal / Director will submit the list of all such candidates by 3<sup>rd</sup> February, 2021 who have failed to submit the proof of eligibility by 31<sup>st</sup> January 2021 and also certify that such candidates have been denied permission to attend the classes. In case the candidate fails to submit his/her final result of qualifying degree in the manner as prescribed above to prove his/her eligibility on or before 31<sup>st</sup> January 2021 whatsoever, the reason may be, his/her admission will be treated as null and void (cancelled) and the entire fee will be forfeited and under no any circumstances he/she will be allowed to appear in the End Term Exam.

No extension beyond 31<sup>st</sup> January 2021 shall be allowed by the University in any case.
