The session featured talks from speakers: Dr. P.V. Madhusudhan Rao Professor, Department of Mechanical Engineering & Design, IIT Delhi and Shri Divyanshu Mishra Assistant Controller of Patents and Designs, Patent Office, Delhi.

Professor P.V. Rao, from IIT Delhi talks about the importance of intellectual property and why it is important to protect one's innovations. He mentions that inventors often have a misconception that if they don't patent their inventions, it will make it easier to share with society. However, he argues that not having a patent can hinder the impact of the innovation because it cannot be commercialized.

Shri Divyanshu Mishra from the Government of India talks about the how aspects of intellectual property. He discusses different types of intellectual property, such as patents, copyrights, and trademarks. He also provides information on how to file for intellectual property protection.

Also Shri Pradeep Dhage, Assistant Director, Ministry of Education Innovation Cell, presented a presentation on various IP tools and Project Management tools along with the funding opportunities available for the researchers and innovators.
