



MEMORANDUM OF UNDERSTANDING

between Maharaja Surajmal Institute of Technology (New Delhi, INDIA) and Wentworth Institute of Technology (Boston, MA, USA)

Maharaja Surajmal Institute of Technology, located at C-4 Block. Janakpuri. New Delhi-110058, INDIA, and Wentworth Institute of Technology, located at 550 Huntington Ave.

Boston, MA USA, (collectively referred to as the "Universities,") is made as of the day of 2023, to explore the development of academic and cultural interchange between the Universities in education, research, and other areas.

Recognizing that there are opportunities for the Universities to partner in order to expand curriculum opportunities, this MOU commemorates our mutual interest in pursuing further dialog relative to the development of Programs, Projects and Activities as described herein. Subject to mutual consent of the Universities, the provisions of the agreement are as follows:

Article I.

The goal of the cooperation between Maharaja Surajmal Institute of Technology, and Wentworth Institute of Technology are as follows:

- to promote interest in the teaching and research activities of the respective institutions,
 and
- to deepen the understanding at each institution of the economic, cultural and social issues relating to its counterpart.

The Universities agree to explore areas of collaboration, which could include any program offered by either university where the two Universities believe collaboration is feasible and desirable, and which would develop and enhance a mutually beneficial relationship between the Universities.

Article II.

To achieve these goals, the Universities may investigate opportunities in any one or more of the following activities or programs:

- i. Study Abroad Program
- ii. Student Projects
- iii. Faculty Collaborations (creation of SIG's, joint seminars and webinars)
- iv. Creating Graduate Pipelines
- v. Joint International Conferences

Article III.

Final agreement to engage in any of these programs shall be commemorated in a formal agreement, subject to the approval of the Heads of each institution, and the availability of funding and other resources. This general Memorandum of Understanding shall be identified as the parent document of any program between the Universities and shall be referenced in any agreement executed between the parties with respect to such program. Further agreements concerning any such program shall provide details concerning the specific commitments made by each University and shall not become effective until they have been reduced to writing and executed by the duly authorized representatives of the respective University.

Article IV.

This Memorandum of Understanding shall become effective upon execution by the Heads of both Universities, and unless sooner terminated will remain in force for a period of five years. Such termination by one University shall be effected by giving the other University at least ninety (90) days advance written notice of its intention to terminate. Termination shall be without penalty. If this Agreement is terminated, neither University shall be liable to the other for any monetary or other losses which may result from such termination.

Any amendment to this MOU shall be based on mutual consent and requires the written approval of the Heads of each institution.
