As you are aware, All India Council for Technical Education has been mandated under the AICTE Act, 1987 to ensure maintenance of norms and standards with regard to technical education in the country. In exercise of this mandate, the Council insists on fulfillment of the minimum requirements prescribed for imparting technical education by the institution so that quality of courses is not compremised and stakeholders are satisfied. The Council also undertakes an annual Enspection of the institutions and conveys deficiencies to them for rectification.

It has been observed however that notwithstanding the Council's repeated advice to comply with minimum norms and standards, many institutions continue to be complatent about taking steps to remark the deficiencies.

Such institutions suffer from critical deficiencies of faculty in proper cadre ratio, qualification, experience and other requirements. Feed back of students with regard to quality of colucation imparted by such institutions has evoked grave concern. The Expert Committees, following molistic appraisal during inspections, have also pointed out severe shortcomings

The institution has been found to be suffering from several deficiencies, which are instead in Annexure-A for your perusal. Shortage of faculty is of gravest concern.

The deficiencies in respect of faculty (including proper cadre ratio & qualification etc.) could have randered your institution liable for punitive action including being placed in no admission/ reduced intake category. However the Council has decided to take a lenicint view and give you yet another last opportunity to rectily the deficiencies particularly with regard to faculty shorage, proper cadre ratio & requisite qualification. (f) That the institutions shall not have any collaborative arrangements with any Indian and/ or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution

- (g) That the Institution shall not conduct any course(s) in the field of technical education in the same premises/ campus and / or in the name of the Institution without prior permission/ approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
- (h) The institution shall not conduct any non-technical course(s) in the same premises/ campus under any circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution

- 3 That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or a collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- 4 That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardians of students in any form.
- 5 That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or persons authorized by it.
- 6 That the Director/ Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time.
- 7

(a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.

- (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/ programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be put on the Institution. Website. The information shall be revised every year with updated information about all aspects of the institution.
- (c) That it shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place
- (d) That a compliance report in the prescribed format along with mandatory disclosures on fulfillment of the above conditions, shall be submitted each year by the Institution within the lime limit prescribed by the Council from time to time i.e. 31<sup>st</sup> August 2007 for the current year.
- (e) That if Technical Institution fails to disclose the information or suppress and/ or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.

#### New Delhi, the 12th January, 2007

No. F. 37-3/Legal/2007.—In exercise of the powers conferred by Sub-section (1) of Section 23 read with Section 10 (b). (o) & (v) of the All India Council for Technical Education Act, 1987 (52 of 1987), following Regulations are hereby notified by the Council

(1) Short title and commencement:-

- (a) These Regulations may be called the All India Council for Technical Education (AICTE) admission of students in Degree Engineering Programmes through lateral entry Regulations 2007.
  - (b) They shall come into force w.e.f. the date of publication in the Official Gazette of India.

#### (2) Definitions:-

In these Regulations, unless the context otherwise requires, -

- (a) "Act" means the All India Council for Technical Education Act.-1987 (52 of 1987);
- (b) "Commission" means the University Grants Commission established under section 4 of the University Grants Commission Act 1956.
- (c) 'Technical Institution'' means an Institution set up by Government, Government Aided and Private (self financing) for conducting courses / programmes in the field technical education, training and research in Engineering, Technology Including MCA, Architecture, Town Planning, Management, Pharmacy, Hotel Management & Catering Technology, Applied Arts & Crafts and such other programmes and areas as are notified by the Council from time to time;
- (d) "University" means a University defined under clause (f) of Section 2 of the University Grants Commission Act, 1956 and includes an institution deemed to be University under section 3 of that Act:
- (e) All other words and expressions used herein and not defined but defined in the All India Council for Technical Education Act, 1987 (52 of 1987), shall have the meanings respectively assigned to them in the said Act;

#### (3) Purpose:-

These Regulations provide for admission of diploma holders and B.Sc. graduates into second year degree programmes in Engineering and Technology through lateral entry.

#### (4) Applicability: -

These Regulations shall be applicable to: "

(b) Universities including Deemed to be Universities of Government, Government Aided and Privilself financing) conducting courses / programs in the fields of technical education, training aresearch in Engineering, Technology including MCA, Architecture, Town Planning, Management Pharmacy, Hotel Management & Catering Technology, Applied Arts & Crafts and such other programs and areas as are notified by the Council from-time to time.

#### (5) Requirement: -

Under section 10 (o) of AICTE Act, it shall be the duty of the Council to take all such steps as it may think fit for ensuring coordinated and integrated development of technical and management education and maintenance of standards and for the purposes of performing the functions under this Act, the Council may provide guidelines for admission of students to technical institutions and Universities imparting technical education.

## 6.1 ADMISSION OF DIPLOMA HOLDERS INTO SECOND YEAR DEGREE ENGINEERING PROGRAMES THROUGH

#### 6.1. (a) Admission of Diploma Holders

Although engineering diploma programmes are conceived as terminal in nature, some flexibility has to be built in to enable the meritorious amongst diploma holders to obtain Engineering degrees. There is evidence of diploma holders pursing an Engineering programme having performed well not only in their academic careers but also in their jobs.

#### 6.1 (b) Eligibility

For being eligible to seek lateral entry to an Engineering degree programme at the second year third semester level, a candidate must have passed the diploma in Engineering in the relevant branch with a minimum of 60 percent in the aggregate. Only candidates fulfilling these conditions would be eligible for appearing in the entrance test meant for selection of diploma holders for Lateral entry to degree programmes. The selection of candidates will be based on an entrance test, the merit ranking in the test being the basis of admission.

At present students obtain diploma through different programmes in different States/UTs. Such programmes have different structures and forms like the semester pattern, annual pattern, sandwich pattern, etc. In order to maintain uniformity, a common entrance examination seems essential. Further, it is necessary to select only meritorious students who have passed the diploma with good academic record.

A student who has acquired a diploma in Engineering through a minimum of three years of institutional study, after 10+(Secondary School Leaving Certificate Examination) can be considered to be academically equivalent to a student who has passed the first year of the four year Engineering degree programme for which the qualifying examination is of the 12+ level.

The Affiliating University may prescribe compensatory courses to make up deficiencies for diploma holders, who are admitted through lateral entry.

#### 6.2(a) Admission of B. Sc., Graduates

Science education in the country is suffered primarily due to lack of exployment opportunities after completion of degree counces. This frend is affected the science education in the country and only a few students are obting to go for the science stream. In order to previde science [[] - म्यमह 4]

students avenues for proper employment opportunities after completing graduation, Science graduates may be permitted to join Engineering courses at second year along with the diploma holders through lateral entry.

#### 6.2 (b) Eligibility:

For being eligible to seek lateral entry to an Engineering degree programme at the second year/ third semester level, a candidate must have passed the Degree in Science (B.Sc.,), with <u>Mathematics as a subject and with a minimum of 60 percent marks in the aggregate.</u> Only candidates fulfilling these conditions would be eligible for appearing in the entrance test meant for selection of B.Sc., graduates for Lateral entry to an Engineering degree programme. The selection of candidates will be based on an entrance test, the merit ranking in the test being the basis of admission.

The affiliating University may exempt B.Sc., degree holders form Science courses and other relevant courses at the second year level and prescribe compensatory courses to makeup deficiencies.

#### (7) Extent of Lateral Entry

Diploma holders and B.Sc Degree holders shall be eligible for admission to second year Engineering degree programmes up to a maximum of 10% of sanctioned intake, which will be over and above the approved intake (supernumerary). In addition, these candidates shall be eligible for admission in the second year against the vacant seats at first year level. The concerned Admission Authority shall decide the ratio between the diploma holders and 8.Sd graduates for admission.

#### (8) Interpretation

If any question arises as to the interpretation of these Regulations, the same shall be decided by the Council.

The Council shall have the power to issue clarification to remove any doubt which may arise in regard to implementation of these Regulations.

#### (9) Power to relax

The Council may, in exceptional cases, for removal of any hardship or such other reasons to be recorded in writing, relax any of the provisions of these Regulations.
