1. In terms of Section 5 (21) of the Indraprastha Vishwavidyalaya Act 1998, with the prior approval of the competent authority, I am to convey the approval for continuation of provisional affiliation to **Maharaja Surajmal Institute of Technology**, for conduct of **B.Tech. (CSE, ECE and IT) programmes** each of 4 years duration with maximum permitted intake capacity of 60 (Sixty only), for the academic session 2004-05. The provisional affiliation is subject to the following conditions: -

- (i) That the society shall adhere to the provisions of the Act, the Statute, the Ordinances and regulations of the Indraprastha Vishwavidyalaya and will comply with the standing order & directions of the University.
- (ii) That the admission for the session 2004-2005 shall be in conformity with the procedure as approved by the University/ State Govt. & institute shall not announce admissions directly under any circumstances.
- (iii) That the course curriculum & fee structure will be as prescribed by the University/ State Govt. for the academic session 2004-05.
- (iv) That the Institute shall be ready to pay the fee as prescribed below:
  - (i) Continuation of Provisional Affiliation fee Rs. 20,000/- for B.Tech. (CSE) programme
  - (ii) Continuation of Provisional Affiliation fee Rs. 20,000/- for B.Tech. (ECE) programme
  - (iii) Continuation of Provisional Affiliation fee Rs. 20,000/- for B.Tech. (IT) programme
- (v) That the institute shall ensure that permanent qualified and experienced Principal/ Director and Head of the Departments remain in position throughout the academic session 2004-05 for smooth conduct of these programmes and to give the institute a better foundation.
- (vi) That the institute will ensure that required qualified, recognized, Professor, Readers and lecturers in the ratio of 1:2:4 and staff remain in position during the academic session 2004-05, dedicated to B.Tech. (CSE, ECE and IT) programmes separately, as per the norms of the State Govt./ University/ AICTE for the sanctioned intake.
- (vii) That the institute will not run any unaffiliated course(s) in the same premises where University approved programme(s) is being conducted. B.Ed being a non-technical course, should be physically separated from this institute so as to maintain the individuality of each institution.



- (iii) That the institute shall keep augmenting the library with latest titles (at least 100 for each programme), required number of volumes, reference books and subscribe at least 10 national and international journals (for each programme), magazines, newspapers relevant to the course curriculum in order to meet the requirement of sanctioned intake of students.
- (x) That the institute shall keep upgrading the configuration of terminals and peripherals with the changing demand, adding more numbers of licensed software and provide Internet connectivity for working hours to make its students and teachers adequately conversant in the relevant field.
- (xi) That the institute shall maintain well-furnished classrooms with necessary instructional aids, adequately equipped labs, computer center with laser printer and relevant software throughout the conduct of these programme(s). The institute should avoid using basement of the institute for academic instructional purposes.
- (xii) That the institute shall organize faculty development/ orientation programmes and student awareness programmes through seminars/ workshops/ conferences for continuing education focused on technical and professional education. The faculty should be motivated for pursuing research and publication of papers in journals of national and international repute.
- (xiii) The institute should upgrade Training and placement cell for effective placement of pass out students and promote industrial interaction/ linkage from time to time for the benefit of students and faculty members.
- (xiv) To ensure maintenance of educational values and quality, the management of the institute should make available a separate budgetary allowance in order to promote excellence and to emerge as an exemplary institution in its own orbit.

2. The compliance report for aforesaid conditions and stipulations of All India Council for Technical Education/ Directorate of Training & Technical Education Govt. of NCT of Delhi should be made available to the University within one week from the date of issuance of this letter.

3. In the event of infringement/ contravention or non-compliance of any of the conditions, guidelines, norms and regulations prescribed by the University/ State Govt. from time to time, the University shall be free to withdraw affiliation and take further appropriate action, with out consideration of any related issues, and the liabilities arising out of such withdrawals would be solely that of the institute

- 2.0 That the Institution / Society / Trust/ Company shall not conduct any full time, part time or distance education programme(s) within its premises without the specific prior permission of the University and will not conduct any programme whatsoever of any other University in the said campus. It will also not use the trademark/trade name of the University for any other admission/teaching activity/conduct of any other programme at any other campus till it remains affiliated with Guru Gobind Singh Indraprastha University.
- 3.0 That the Institution / Society / Trust/ Company shall ensure that ragging is completely banned among student community and prohibited in the campus and hostels of the institute/college. Some teachers shall be made responsible in order to guarantee implementation of this Order of the Government.
- 4.0 That the Institution / Society / Trust / Company shall create special facilities such as ramps, rails and special toilets and make other necessary arrangements to suit the special needs of physically challenged persons.
- 5.0 That the Institution / Society / Trust / Company shall ensure availability of Principal / Director, faculty and non-teaching staff qualified and adequate as per the norms of University / Statutory Body in respect of each programme conducted throughout the session.



- 6.0 That the Institution / Society / Trust / Company shall ensure maintenance of its class rooms, laboratories, computer centre, library, common rooms, faculty rooms, seminar hall/ conference room, ambience etc., as also the augmentation of the library, labs, computer centre as and when required as per the demand of the course curriculum.
- 7.0 That the Institution / Society / Trust / Company shall follow the course curriculum, examination scheme and fee structure prescribed by the University / State Govt. and will not charge any unauthorized additional fee on any account like providing Book Bank facilities / placement facilities to the students, conducting lectures / seminar / workshop, etc. for knowledge / entrepreneurship development of students (expenditure for which shall be preferred to be met out from the Institute's share of student activity fees) or any advance fee for the next session.
- 8.0 It will also be ensured that security deposits of students and their original certificates are returned back in appropriate manner and within stipulated time. The students of the Institute shall not be harassed in this context. Further, no student either passed out and / or pursuing studies at your Institute shall be discriminated on the ground of gender.
- 9.0 That the Institution / Society / Trust / Company shall upload the specifications of land, built-up area, land use, etc., aside status of faculty and other academic facilities available, categorically on its website indicating the courses with intake allowed to be conducted by the University so that the students are well aware of the quality standards maintained by the institute. Any developments regarding change in faculty, academic facilities etc. shall also be displayed on the website within a week so that there is total transparency in conduct of the programme.
- 10.0 That the Institution / Society / Trust/ Company shall organize faculty development and student awareness programmes through seminars, conferences and workshops etc. in order to maintain quality standards and promote excellence in imparting education. Value education shall be a part of overall development of the students and the institution / society shall take measures to promote it.
- 11.0 The Institution / Society / Trust / Company shall not without the previous permission of the University suspend instructions in any subject or course of study, where it is authorized to teach a programme or impart education.
- 12.0 That the Institution / Society / Trust / Company shall submit a feedback / compliance report after every quarter highlighting the status of faculty and indicating its academic progress. In case any complaint is referred by the University regarding the institution or any of its component, it will be the responsibility of the institution / society to submit compliance and rectify the deficiency / discrepancy in a time bound manner.
- 13.0 That the Institution / Society / Trust/ Company shall setup an Internal Complaint Committee under the "The Sexual Harassment of Women at Workplace (Prevention, Prohibition & Redressal) Act, 2013 and send yearly report to UGC, Women's Commission".
- 14.0 That the Institution / Society / Trust / Company shall setup a Grievance Redressal Committee to address / resolve the grievances of students as per directions of Hon'ble Supreme Court in W.P.(C) No. 793/17. The constitution of committee shall be displayed properly in the institute.
- 15.0 That the Institution / Society / Trust / Company ensure installation of appropriate Fire Safety equipments and availability of valid Fire Safety Certificate from concerned Government department.
- 16.0 That the Institution / Society / Trust / Company ensure that the deficiency/ shortcomings/ suggestions pointed out by JAC as mentioned in the NOC of GNCTD have been resolved / complied with. If not, the same has to be complied latest by 30.09.2024.
- 17.0 This provisional affiliation letter is being issued subject to submission of a duly notarized undertaking by the Institute on the Non-Judicial Stamp Paper of Rs.100/- in the enclosed format within 15 days of the issue of this letter.



In the event of infringement / contravention/ non-compliance or flouting of the University Norms/ Govt. Policy Guidelines/ Statutory Body Standards, the University shall be constrained to take an appropriate action and shall be free to withdraw affiliation and the liabilities arising out of such withdrawals would solely be that of the Institution / Promoting Society/ Trust/ Company.
