
MSME Scheme Overview

Business Development Session

Shri. Sunil Kumar, IEDS Assistant Director, Gr. I, gave a comprehensive brief about how to start your own business and explained various MSME schemes beneficial for aspiring entrepreneurs. He introduced a book titled "Who Can Become Rich" and shared its four crucial principles for successful entrepreneurship. He provided valuable guidance on building a business plan, covering aspects of marketing, finance, technology, and the benefits of MSME schemes. He also discussed the GeM scheme, Delayed Payment Act, and the IC Champions scheme. He concluded his session with a beautiful quote: "It does not matter how many resources you have; if you don't know how to use them, you will never succeed."



NSIC Support Programs

Ms. Madhu Malti, Deputy General Manager (Retd.), NSIC, provided detailed information about NSIC's core principles and encourages both new and existing entrepreneur. She covered diverse business opportunities including bread making, biscuit manufacturing, soya bean to milk processing, spice branding and packaging, and marketing strategies for competitive markets. Her practical insights were highly appreciated by the audience.





Banking and Financial Support

Shri R.K. Singh, Lead District Manager, State Bank of India, detailed several key financial schemes available to startups, including Mudra loans up to ₹10 lakh with easy access, Stand Up India loans ranging from ₹10 to ₹15 lakh focusing on SC/ST and women entrepreneurs, and government subsidies between 15 to 35 percent with no income ceiling or educational restrictions. Additionally, service sector loans up to ₹20 lakh and manufacturing loans up to ₹50 lakh are offered with low margin requirements. He emphasized that banks act as custodians of public funds.



Conclusion

Prof. Neeru Rathee, Convenor, concluded the meeting by thanking the distinguished guests and members of the eCell society, as well as the audience for their active participation in this enriching seminar. During the interactive question-answer session, one audience member inquired about civil score requirements, which was comprehensively addressed by R.K. Singh Sir.
